8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and the staff of the school.

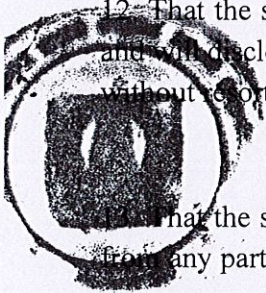

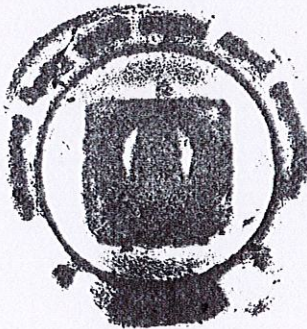
14. That the school shall strive to make efforts for conservation of environment.
